The Ilanka Community Health Center On-Call Clinic Housekeeper works on an On-Call Basis, as needed, with the Clinic Housekeeper, or to cover Clinic Housekeeper absences. Duties listed below are a general representation of most tasks. Detailed processes will be provided upon hire. Position is expected to work under the guidance of the Clinic Housekeeper and Nursing Coordinator.

The incumbent performs a variety of routine work within established policies and procedures and receives detailed instructions on new projects and assignments.

Responsibilities/Duties

- Cleaning and disinfecting of clinic space.
- Cleaning of NVE housing, as needed.
- Participate in infection control training.
- Cleaning includes, but is not limited to:
 - Windows, floors, restrooms, and other areas of clinic to ensure patient and employee safety.
 - Disposal of wastes in wastebaskets as well as clean the wastebaskets.
 - Appropriate disposal of medical waste products like syringes, hand gloves, face mask, sachets of tablets, etc.
 - Dusting of furniture, fixtures, and equipment.
 - Replenishing soap and paper supplies.
 - Disinfecting areas where there may have been blood or bodily fluid contact.
 - Using various types of cleaning equipment, like vacuum cleaners, washing machines, etc.
 - Documenting the procedure involved in the disposal of clinic waste products and ensure that the right procedure in line with the standard practice of the clinic, is followed.
- Other duties as assigned.

Competencies (Knowledge, Skills and Abilities)

- Good organizational skills as well as strong hygienic practice.
- Mathematical skills needed to mix cleaning agents appropriately in accordance with the prescription of the manufacturer.
- Proven ability and/or inclination to follow instructions.
